October 16, 1890

Phillip KLINE, an iron workman in the court house, was engaged in a conversation near the Boody House when his wife and sister-in-law approached him. He has been long seperated from both. His wife aimed a blow to his head with her umbrella but missed; his sister-in-law thrust the point of hers into his eye, inflicting a painful wound.

Erastus R. McDONALD died at Joplin, Missouri, 7 Oct; Born in Edinburgh, Pa. 14 July 1844; came to this county with parents; enlisted in Civil War; worked as salesman in Bryan dry goods and clothing store.

Fire on May 6 at building owned by W.D. BAILEY at Waldron, Michigan; Frank SHUTT, a carriage painter, formerly of Bryan, now Defiance, turned over incriminating letters from a woman. George SMITH was arrested as was BAILEY; likely to be convicted.
